Notes to the Unaudited Consolidated Financial Results for the quarter and nine months ended December 31, 2023:

- 1 The above unaudited consolidated financial results of AVG Logistics Limited and its subsidiaries ('the Group') along with its associates have been prepared in accordance with the recognition and measurement principles of the Indian Accounting Standards ('Ind AS') as notified under the Companies (Indian Accounting Standards) Rules, 2015 as amended by Companies (Indian Accounting Standard) Rules, 2016 prescribed under Section 133 of the Companies Act, 2013 ('the Act'), and other accounting principles generally accepted in India and is in compliance with the presentation and disclosure requirements of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (as amended) including relevant circulars issued by the SEBI from time to time.
- 2 The above unaudited consolidated results were reviewed by the Audit Committee and approved by the Board of Directors in their meeting held on February 14, 2024. The above consolidated results for the quarter and nine months ended December 31, 2023 have been concluded by the Statutory Auditors of the Company. The unmodified review report of the Statutory Auditors is being filed with the BSE Limited and National Stock Exchange of India Limited.
- 3 Attention is drawn to the fact that the figures for year to date up to the end of the third quarter of the previous financial year (including the quarter ended December 31, 2022) as included in the Statement have not been subject to limited review or audit. However, the Company has exercised necessary due diligence to ensure such financial results provide a true and fair view.

1. We have reviewed the accompanying Statement of unaudited consolidated financial results of AVG Logistics Limited ('the Holding Company'), its subsidiaries (the Holding Company and its subsidiaries together referred to as the 'Group') and its share of the net profit after tax and total comprehensive income of its associates for the quarter ended December 31, 2023 and the year to-date results for the period from April 1, 2023 to December 31, 2023 ('the Statement'), being submitted by the Holding Company pursuant to the requirements of Regulation 33 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended ('the Regulations'). 
