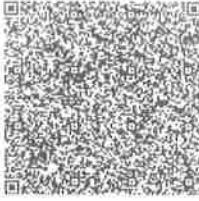

AND

Cogniferentials Consultancy Private Limited, having its office at A 310 Pocket P2 Oil Co-op, Housing Society Limited, Knowledge Park-I, Gautam Buddha Nagar, Maicha, Uttar Pradesh, India through its Director Mrs. Himangi Singh (hereinafter referred to as the “**Service provider**”, which expression shall, unless repugnant to or inconsistent with the context or meaning thereof mean and include its successors and permitted assigns), of the **SECOND PART**
